EnCel - The Company was developing nonpolluting, silent heat-to-electric conversion technology products to power military sensors and telemetry, portable generators, remote power sources, residential heating/ cooling, and RV battery supplements. The patented technology is known as Alkali Metal Thermal-to-Electric Conversion, or AMTEC. According to its website, "EnCel, LLC holds exclusive licenses to the original Ford AMTEC patents and has since expanded the technology. EnCel holds an additional seven patents on the technology, with other applications and patents pending," In addition, the firm is "continually evaluating opportunities to commercialize our current state of technology...great effort is being undertaken to design for manufacturability and to reduce costs."
